Philosophy of the Human of the Metagalaxy

Annotation. The article contains the idea of the development of the Human and the Humanity in their interrelation with the more grand-scale environment of living than the Earth is – the Metagalaxy system. The basis for such a view are several fundamental concepts about the Human and the Humanity, such as self-organizing system, the Anthropic principle of the Human creation, system-hierarchical principle of matter organizing, which also includes biological matter of the Human. The logical method of the point of view justification is applied.

The eye position of the investigator determines the result of the observation. The result depends on that, with what kind of knowledge, senses and mindset of investigator the object is explored. Besides, the investigator and the object of research affect each other, being both the subjects of mutual changes effects.

Modern viewpoint about the conception of Human should consider and unite miscellaneous theories of the Human nature. This approach is being demanded by the age of globalization and synthesis of often controversial opinions, attitudes, theories.

Let's consider the most significant achievements of philosophy and science during the 19-20th centuries.

The whole Earth – is the system of a wide range of conditions of the Humanity development, and it has been regarded as a solid organism, which exists in conformity with the laws of self-organization.

The Earth is a semi closed system, sharing the uniform conditions of existence with the Solar System (and may be not only with it), and those conditions indirectly affect the Earth. And also the Earth has its system-hierarchical organization of its home natural and biological, humanitarian, social, civilizational, economic and other conditions and characteristics.

Any self-organizing system has its growth periods and, achieving its development capabilities limits, has to turn into the qualitatively new condition with qualitatively new hierarchically higher values, - that's the law of the evolution.

Considering that the Earth system is regarded as a whole solid system, the evolutionary process affects all the conditions and parameters of the Earth, including the Human.

The Humanity faces the exact challenge to meet: what is the direction of the humanitarian development vector? What is the image and representation of the Human, which we should achieve and obtain?

In accordance with the Anthropic principle, the concentration of all the potentials and sources, conditions of development of the civilization and its capabilities, belong to the Universe. The system which is creating the Human, – that is the system where we should look for the perspectives of the Humanity growth. Thus, we come to the logical conclusion: the perspectives of the Humanity growth belong to the more grand-scale system – the Universe or Metagalaxy (to avoid the religious associations) system.

Let's revise the dialectical law of quality-quantity-ratio. If one quantitative parameter changes, it results in the appearance of the conditions of qualitative changes. If the environment which is concentrating upon the Humanity is being acclimated by the Humanity with its higher parameters and values (Metagalactic ones), the Humanity transfigures in a qualitative manner, i.e., there appear and start to develop the immanent and self-evolution characteristics, qualifications and capabilities of the Human.

It is also logical to assume that in order to be able to expand to new territories and matters (which belong not only to the Earth), the Human is to have the high and cultivated mind, conscious, mentality, etc. of a completely different quality.

The image of the Human of the Future (let's call him the Human of the Matagalaxy) represents the Human, living on the Earth (while we haven't yet expanded to other planets), but with his/her vibrations of thoughts, feelings, consciousness, intelligence the Human appeals to the Metagalaxy, cognizing it.

Let's remember the law: the investigator affects the object of the investigation. And vice versa. Tuning in to the right wave-length of the Metagalaxy matters with our cogitative functions, we will inevitably draw its reaction upon us. The reaction, creating us. Little by little there appears the mutual expression of presence of the Human in the Metagalaxy, and the Metagalaxy in the Human. Gradually there will grow reflection of the Metagalaxy in each Human, as well as of its matter values and parameters. And this may mean only the following: the features of a variety of the multidimensional matters of the Metagalaxy realities (according to the modern scientific data, the Metagalaxy indeed has a variety of multidimensional realities) are to find their reflection in the Human, via the same variety of biological anthropic types of matter (the law of similarity).

Each kind of biological matter differs from the others with its functionality. For the Human this means the development of the present functions to the new higher quality level, and even the birth of the new ones.

For example, the development of the function of brain "holoversum" with the appearance of the capability not only to reflect the picture of the outside world, but also to affect it with one's formative abilities.

For example, to cogitate the surrounding environment not only via one's feelings and reflection principle features, but via giving birth to the new matter images of thoughts by way of synthesizing the objective multidimensional laws and parameters at the very moment of cogitation.

For example, via concentration of energy of forces, essences and senses to precipitate and enhance the process of generation of a definite character: to achieve definite skills, abilities, and even to generate and develop new capabilities.

And one more thought: there is a philosophical law of the balance of the internal and external. Having been adhered for quite a long time to the technological way of development, we are now at the moment when we have to change the alignment point of the Humanity development, turning to the growth of the Humaneness. Since it is Human, who creates the enginery, not vice versa. The Human is biologically higher than any technical object.

Hence there are the immediate objectives in the Humanity development: the humanitarian development of the space. The technogeneous way of development, as the one of a lower evolutionary level, gets the boon only after the humanitarian one, since it's the Human who gives rise to it.

Conclusion:

Thus, the Human of the Future, the Metagalactic Human, living on the Earth, is being coorganized via the mutual living environmental field with the Sphere of the Metagalaxy, as the whole solid system with a variety of hierarcichalized and intersynthesized matters (which have a mutual expression of their presence in each other in their coevolution development).
